<b>11 to 20 Minute Telephone Call with Therapist</b> Payable on Next Session with Therapist	\$40.00
<b>21 to 30 Minute Telephone Call with Therapist</b> Payable on Next Session with Therapist	\$60.00
<b>Charges for Telephone Calls Longer than 30 Minutes</b> Payable at Next Session with Therapist	\$20.00 per Additional 15 Minutes
<b>Report Preparation to Other Professional (\$25.00 Records Search/Admin Fee + 50.00 per 15 minutes of Preparation Time/\$200.00 an hour)</b> <b>\$100.00 Advance Deposit</b> Balance Payable at the Time of Delivery of the Report	\$25.00 + 15-minute increments
<b>Letter of Support or to a Third Party – Simple (1 to 2 Pages)</b> Payable on Delivery of the Letter	\$25.00
<b>Letter of Support or to a Third Party – Complex (2 Pages or More)</b> Payable on Delivery of the Letter	\$50.00
<b>Interaction with Other Professionals (Lawyer, GAL etc.) per hour/one</b>	\$250.00.
